PRIMARY FUNCTION

The Director of Foundation and Government Relations is a key frontline leadership member of the advancement team at Bennington College and is responsible for providing strategic and proactive

oversight to grow institutional giving in order to maintain and expand existing relationships and securing new funding opportunities from government sources, family foundations and other institutional funders. This critical institutional role, proactively taking initiative to oversee, manage and enhance a growing portfolio of foundation funders and potential government agency funding, will provide leadership and expertise to advance the College's needs, interests and priorities by fostering and creating productive relationships with external funders, researching and identifying external sources of institutional support, and seeking opportunities to generate new proposals based on funders' guidelines and interests. The placement will foster a culture among faculty and staff of interest in grantsmanship. The Director will balance equally important external and internal relationships, incorporating direction given through strong partnership with the College's leadership and in collaboration with faculty, to generate the relationships, dynamic proposals and reports that lead to enhanced program outcomes.

Reporting to the Vice President for Institutional Advancement, and working collaboratively with the advancement team, the Director is accountable for stewarding existing relationships and developing new connections to help strengthen Bennington's network of current and prospective institutional donors. They will work closely with the President, Provost, Cabinet, and faculty members to conceptualize and develop grant proposals, working across departments to co-develop concept papers and proposals, including budget and financial data. The Director will write, refine, and edit proposals and reports, and ensure timely communications related to foundation and select government funding.

POSITION DESCRIPTION

The Director of Foundation and Government Relations works with members of the Institutional Advancement, Communications Office, President's Office, Business Office, Dean's Office, and additional campus offices. The Director also has external relationships with foundation contacts, Trustees (as required), alumni, parents, students, and friends of Bennington College.

Role and Responsibilities:

- Strategize with the President of the College and the Vice President for Institutional Advancement to create and execute the strategy to expand support from family and institutional foundations as well as government funders in order to reach annual fundraising goals and build a robust pipeline for future growth.
- Meet the annual Foundations and Government Relations revenue goal, including proactive identification of new institutional funders, and cultivation, solicitation, and stewardship of existing funders.
- Research new sources of funding, forming relationships with program officers and/or senior leadership of foundations, government and corporate sponsors.
- Draft persuasive and clear letters of intent and proposals based on a full understanding of the interests and motivations of each potential funder.
- Collaborate with colleagues in adjacent departments to support and expand foundation fundraising and partner with the President and Cabinet members to steward funders and to develop strategy.
- Oversee post-award documentation compliance, including personalized thoughtful grant acknowledgements, and relevant mid-cycle stewardship.
- Lead the process of preparing required reports to foundation and government funders, including submission of budgets in collaboration with the financial office.
- Maintain a calendar of tasks and deadlines as it pertains to this work.
- Assist in other Institutional Advancement writing projects and presentations, as needed.

Critical Competencies:

- Track record of working with national foundations and understanding their priorities and matching those to internal research; experience preparing required reports to foundation and government funders, including submission of budgets in collaboration with the financial office.
- Experience building momentum for an institutional giving function in higher education and the arts; relationships with funders and success in connecting funders to faculty and programs.
- History of building culture of grantsmanship among staff and faculty; build trust among academic community to mobilize participation in grant-seeking.

- Cultivate and grow corporate and government funding sources and relationships while working with Major Gift Officers to deepen relationships with private foundations.
- Redefine the role as a relationship lead and service-oriented proactive fundraising arm.
